- Only food and non-alcoholic beverage vendors will be accepted
- Mail completed application & signed waiver, along with a check in the amount of \$50 to Main Street Pinedale at PO Box 2529, Pinedale, WY 82941. *Before February 11, 2019*
- The \$50 fee allows you to be a vendor for all 3 days of the Pinedale Winter Carnival at the Cardboard Classic Race and the Skijoring Races.
- Vendors are responsible for providing their own booths, generators, tables, chairs, tents, and any additional equipment needed, etc. Electricity is not available at any of the Pinedale Winter Carnival event sites.
- Main Street Pinedale reserves the right to assign final vendor location at the event.
- There will be no refunds for cancellations or no-shows after February 13th, 2019.
- No security will be provided at the event. Vendors are responsible for securing all items related to their setup.
- ***Vendor must be in compliance with all Town, County, and State Regulations, including insurance coverage when applicable.***

**VENDOR WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT FOR
THE PINEDALE WINTER CARNIVAL FEBRUARY 16-18, 2019**

As a vendor, I understand that this waiver of liability, assumption of risk and indemnity agreement must be signed in order for me to participate in the Winter Carnival and its events from February 16 - 18, 2019. I understand and acknowledge that my services will be provided only at the site assigned to me. I understand that representatives from Main Street Pinedale, Sublette County, and/or the Town of Pinedale reserve the right to ask a vendor to leave if the vendor, the vendor's conduct or products or services are contrary to the values and principles of the Winter Carnival or otherwise violate conduct codes set forth by Sublette County and/or the Town of Pinedale. In consideration for being permitted to participate as a Vendor in the Winter Carnival (hereinafter called the "event"), I hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE, Main Street Pinedale or the property owners of the premises of the event and their respective officers, heirs, administrators and employees or representatives (hereinafter referred to as "RELEASEES") from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, that may be sustained by me or my organization, or any of the property belonging to me or my organization, WHETHER CAUSED BY NEGLIGENCE OF THE RELEASEES, or otherwise, while participating in the event, or while in, on or upon the premises where the event is being conducted. I understand that in order to receive a site, I must assume all responsibility and risk associated with all conditions, hazards, and potential dangers in, on or about a site, whether they are open and obvious or concealed. I hereby elect to voluntarily participate in said event with full knowledge that said event may be hazardous to me, my organization, and our property. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE, OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by me and my organization, or any loss or damage of property owned by us, as a result of participating in said event, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE. I further hereby AGREE TO INDEMNIFY AND FOREVER HOLD HARMLESS THE RELEASEES from any loss, liability, damage or costs, including court costs and attorneys' fees, that they may incur due to my participation in said event, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES or otherwise or contingent or otherwise, resulting from or arising out of any of my acts or failure to act in connection with my services provided during the event. It is my express intent that this Waiver of Liability and Indemnity Agreement shall bind me and the members of my organization, and my heirs, assigns and personal representative(s), if I am deceased, and shall be deemed as a RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE, the above-named RELEASEES. I hereby further agree that this Waiver of Liability and Indemnity Agreement shall be construed in accordance with the laws of the State of Wyoming. IN SIGNING THIS RELEASE, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Waiver of Liability and Indemnity Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representation, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this Release for full, adequate and complete consideration fully intending to be bound by same.
